Cedar Point Nursery v. Hassid: New Territory on Takings? | 1.5 MCLE

In the case of Cedar Point Nursery v. Hassid, decided on June 23, 2021, the Supreme Court of the United States struck down a California labor regulation requiring farm owners to allow access to their properties so that labor unions could recruit farm work employees because it constituted a per se physical taking of private property without just compensation and was therefore a violation of the Fifth ad Fourteenth Amendments of the U.S. Constitution. The case was the latest in a series of SCOTUS decisions bolstering private property rights in response to government impositions upon private property for public purposes, the upshot being "that government-authorized invasions of property - whether by plane, boat, cable, or beachcomber, - are physical takings requiring just compensation." But where might commonly utilized conditional use permits or restrictions or entries upon private property for inspections cross the line into regulatory takings? How will the Cedar Point decision impact local and state governmental authority in the context of land use, planning, and the exercise of police powers for the protection of public health, safety, and welfare?

Senior Attorney with the Pacific Legal Foundation, Damien Schiff, who was on brief in the Cedar Point case, UVA law Professor Julia Mahoney, an expert on property and constitutional law, and our own Sharon Pandak, a recognized expert on condemnation and takings law, will discuss these issues and the potential impact of Cedar Point Nursery v. Hassid.
