- Common stumbling blocks and conundrums such as insufficient motions for closed sessions, incomplete or untimely responses to documents/information requests, misapplication of working papers exemption, etc.; managing the serial requestor; untangling new rules regarding production of investigative files.
- Litigation practices under the Act, including FOIA motions practice and trials in General District Court, limitations of claims, interacting with pro se plaintiffs, and the intersection of FOIA with discovery.
