Ms. Han will discuss LEO Decertification and Internal Affairs Records issues providing the relevant code sections, the process in practice, the role of LEA and DCJS, and FOIA implications for IA records.

This presentation will provide insights into the technology trap and offer advice for maintaining well-being and ethical compliance in the age of legal technology.

This session will focus on short-term rentals, specifically in smaller jurisdictions. Currently counties, cities, and towns all handle short-term rentals very differently. Some localities have no regulations, meaning you need no zoning or building permits to host guests for a fee. Some localities require a special use permit and place various conditions on these rentals. Recently there have been several challenges by property owners to zoning regulations placed on short-term rentals, arguing that short-term rentals cannot be regulated because they fall under the umbrella of agritourism. The speaker will review the Attorney General's Opinion and how it could limit the ability to regulate short term rentals, discuss regulations/conditions that may work for localities and explore other options such as short-term rental registries, and show how small localities can enforce its zoning code and tax code.
